

Penticton Pickleball Club - PARTICIPANT AGREEMENT – April 2021

In this agreement, “participant” includes all club members, players and spectators who attend the outdoor courts during designated Club time.

All Participants of the Penticton Pickleball Club agree to abide by the following points when using the courts during Club time at 2965 South Main Street, Penticton, BC, or participating in Club activities under the COVID-19 Response plan and Return to Play Protocol:

- I agree to self-assessment screening checks prior to entering the facility, and will let PPC know if I have experienced any of the symptoms in the last 5 days.
- I agree to stay home if feeling sick, and remain home for the recommended self-isolation period (14 days) if experiencing COVID-19 symptoms.
- I agree to use my own sanitizer and sanitize my hands upon entering and exiting the facility, with soap or sanitizer.
- I agree to sign in or provide my name to the court host/captain on the provided attendance sheet, and understand that these records will be maintained by the club for a minimum 30 days. Signing my name indicates a self-assessment of my health immediately prior to entering the courts has indicated no symptoms.
- Participants are required to provide their own balls for play. It is an option, but not required, that each person plays/serves with their own ball.
 - At the end of the rally, balls will be kicked or paddled back to the server
 - At the end of a game, move to the kitchen line and raise your paddle in the air as a gesture of sportsmanship, no tapping of paddles with opponents or partners
- I agree to continue to follow social distancing protocols of staying at least 2m away from others when entering/leaving the facility, in between games and off the court areas.
- Participants must leave the court at the designated end time, and be away from the facility within 5 minutes.
- I agree to abide by all of the PPC’s COVID-19 policies and guidelines even if they change during the duration of the playing season.
- I understand that if I do not abide by the aforementioned policies and guidelines, I may be asked to leave the club for up to 14 days to help protect myself and others around me.
- I acknowledge that continued abuse of the policies and/or guidelines may result in suspension of my club membership temporarily, and there will no refunding of my membership fees if I am suspended.
- I acknowledge that there are risks associated with entering club facilities and/or participating in Pickleball, and that measures taken by the Club and participants, including those set out above and under the COVID-19 Response Plan and Return to Sport Protocols, will not entirely eliminate those risks.

Booking/Playing Procedures

1. Maximum of 18 singles players (including Court Host/Captain) per session (6 courts.)
2. Maximum of 18 household doubles teams (including Court Host/Captain) per session (6 courts.)
3. Court Host/Captain’s will determine format including:
 - a. # of courts for skinny singles and full court singles;
 - b. Format used – round robin, King’s court, levelled play etc.
4. Maximum of 2 players, or 2 household doubles teams on court surface at any one time, all others must wait outside court areas.
5. Players waiting outside court must wear a mask unless maintaining minimum 2 meters physical distancing.
